RESOLUTION NO. 2011-11

A RESOLUTION DESIGNATING THE CITY MANAGER OF THE CITY OF ROMA AS AUTHORIZED REPRESENTATIVE OF THE CITY OF ROMA TO GIVE NOTICE OF INTENT TO REIMBURSE EXPENDITURES WITH PROCEEDS OF TAX EXEMPT OBLIGATIONS.

WHEREAS, the City Council (the "City Council") of the City of Roma (the "City") may from time to time undertake certain capital improvements or acquire personal property which constitutes the acquisition of capital assets for authorized purposes, all of which constitute expenditures for a public purpose authorized under state law; and

WHEREAS, payment for these capital expenditures will be authorized by the City Council and paid for out of available general funds of the City; and may be paid with proceeds of tax exempt obligations; and

WHEREAS, pursuant to Section §1.150-2(e) of the U.S. Treasury Regulations, notice of official intent to reimburse by the City for its current expenditures of general funds with the proceeds of tax-exempt obligations is required to be given by the City or an appropriately authorized public official of the City in order for these expenditures to be reimbursed upon receipt of proceeds from the sale of tax-exempt obligations;

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ROMA


Section 1. The City Council hereby adopts the findings set forth in the preamble hereof and hereby gives notice of its intent to incur expenditures from time to time that may be subject to reimbursement with the proceeds of tax exempt obligations.


Section 2. The City Manager of the City of Roma is hereby designated as the authorized representative of the City to give notice of intent to reimburse expenditures with the proceeds of tax exempt obligations.

Section 3. The City Secretary shall record this resolution and shall post same at the official bulletin board of the City and make it continuously available for inspection by the general public during normal business hours for 30 days from the date hereof on business days beginning within 3 days after the date of this Resolution.

**A NOTICE OF INTENTION TO
REIMBURSE PROJECT EXPENDITURES**

The undersigned, authorized by resolution of the City Council (the "City Council") of the City of Roma (the "City"), gives notice of intent to reimburse the City for certain qualified expenditures made or to be made no earlier than 60 days prior to the date hereof, and to undertake certain capital expenditures as authorized under state law, consisting of the expenditures described in Exhibit "A" attached hereto (the "Project").


The City is proceeding with the Project and the City anticipates that no earlier than 60 days prior to the date hereof and prior to the issuance of any debt obligations, the City is or will be obligated to make certain expenditures with respect to the Project.

The City will be required to expend funds out of its general fund or other available funds to pay for the expenditures. The expenditures are for governmental purposes and will originally be paid from a source other than proceeds of tax-exempt obligations.

The maximum principal amount of tax-exempt obligations which the City expects to issue for the projects is \$3,571,000


This is a "declaration of official intent" pursuant to and within the meaning of Treasury Regulations §1.150-2, as promulgated under the Internal Revenue Code of 1986, as amended.

NOTICE OF INTENT TO ISSUE

CITY OF ROMA, TEXAS
CERTIFICATES OF OBLIGATION, SERIES 2011

TAKE NOTICE that the City Council (the "*City Council*") of the City of Roma, Texas (the "*City*"), shall tentatively convene at 6:00 o'clock p.m. on the 19th day of December, 2011, at its regular meeting place in the City Council meeting room located at 77 Convent Street, Roma, Texas and during such meeting, the City Council will consider the passage of an ordinance authorizing the issuance of certificates of obligation in an amount not to exceed \$3,571,000 for the following purposes: to construct a storm drainage system and payment of cost of issuance of the Certificates of Obligation. The Certificates of Obligation will be payable from a combination of the City's ad valorem tax within the limits authorized by law on all taxable property of the City, and (if necessary) a pledge of \$1,000 from the net revenues from the operation of the City's waterworks and sewer system. The Certificates of Obligation are to be issued, and this notice is given, under and pursuant to the provisions of the Certificates of Obligation Act of 1971, as amended, Local Government Code Section 271.041 through Section 271.063.




